Prospect Street – Traffic Calming Strategy Presentation and Survey

Dear Resident,

A proposed strategy to implement traffic calming measures on Prospect Street has been developed by the Local Road Safety Committee (LRSC). The proposed measures are intended to address and mitigate traffic issues discussed at the initial Neighborhood Information Session held on March 30, 2022.

A follow-up Neighborhood Information Session to present the proposed strategy has been scheduled for the evening of:

Tuesday, June 28, 2022 at 6:30 p.m. via the Zoom on-line platform.

Enclosed you will find a sketch of the proposed traffic calming measures. Also enclosed, please find a resident survey form regarding the proposed traffic calming measures. The responses to this survey will be used to gauge appropriate stakeholder support for the strategy.

If you have an opinion on the proposed traffic calming measures and how they may impact traffic, noise, your commutes, or other matters, it is important that you respond to this survey. In order for the strategy to proceed towards implementation:

- Greater than 50% of the benefitting properties* must respond in support of the measure
- Not greater than 50% of the interested properties* may respond in non-support of the measure

*For purposes of evaluating the survey results, the “benefitting properties” are those properties that directly front on the street (or portion of street) where the traffic calming measures are proposed. The “interested properties” include the benefitting properties plus other nearby properties for which it is deemed that residents are likely to use the street where the traffic calming measures are proposed as a primary access route.

Survey responses may be either mailed to the Town at the address provided on the survey form; or they may be emailed to:

Please note that no more than one survey response will be counted for any property. To be counted, the survey response must be deemed to represent the opinion of all of the record owners of the property. The survey form must also be completed in full in order to be counted. The determination of if any survey response qualifies to be counted rests solely with the LRSC. **Renters** may respond if they receive proper authorization from the owner(s) of the property they reside at.
