A summary of the August 25, 2025 Bloomfield Town Council Meeting

## ANTHONY C. HARRINGTON VOTED MAYOR BY TOWN COUNCIL

A Special Meeting of the Town Council was held on Monday, August 25, 2025, to vote on Council leadership vacancies that were created by the resignation of former Mayor Danielle C. Wong. In accordance with Section 302 of the Bloomfield Town Charter, the Council convened in Council Chambers to conduct the official vote for a new Mayor and, subsequently, a new Deputy Mayor to fill the remaining leadership roles.

By a vote of 6-1, the Council voted to appoint former Deputy Mayor Anthony C. Harrington as the Mayor for the remainder of the Town Council term, which concludes in November. Mayor Harrington has served on the Town Council for each of the last two terms, holding the position of Deputy Mayor since May 8, 2023, and will now assume the responsibilities of Mayor for the duration of the current term.



## CINDI A. LLOYD VOTED DEPUTY MAYOR BY TOWN COUNCIL

The vote for Mayor created a vacancy in the leadership role of Deputy Mayor and, in accordance with Section 302 of the Bloomfield Town Charter, the Town Council acted to vote for a new Deputy Mayor during the same Special Meeting.

This step was necessary to ensure that the Council's leadership team remained complete and able to fulfill its responsibilities for the remainder of the term.



By a vote of 5-1-1, the Council voted to appoint Councilwoman Cindi A. Lloyd as the new Deputy Mayor for the remainder of the Town Council term, ending in November. Councilwoman Lloyd has been an active member of the Council and will now assume the duties of Deputy Mayor, supporting the Mayor and working closely with fellow Council members to continue serving the residents of Bloomfield.

## TOWN COUNCIL ADOPTS RESOLUTION REGARDING EAST COAST GREENWAY STUDY

The Town Council voted unanimously to adopt a resolution regarding recommendations made for the preferred alignment of the East Coast Greenway as presented in the study conducted by the Capital Region Council of Governments.

The study recommends a 6.2 mile route in Bloomfield, consisting of new multi-use shared paths, rail-with-trail segments, and sidepaths as well as key connections to other bicycle and pedestrian infrastructures and destinations.
