The Electors of the Town of Bloomfield are hereby warned to meet at their respective polling places on Tuesday, November 4, 2025, for the following purpose:

1. To cast their votes for Town Council, Board of Education, Town Plan & Zoning Commission, Town Plan & Zoning Commission Alternate, Zoning Board of Appeals, Zoning Board of Appeals Alternates, and Library Trustees.

Such election will begin with early voting on October 20, 2025 through November 2, 2025. The early voting location will also offer Same Day Registration (SDR). The hours of voting during early voting/SDR will be as follows:
