In accordance with Sections 6. and 14. of the Inland Wetlands and Watercourses Commission Regulations, you are hereby notified that a Violation of the Regulations exists on your property at:

69 Charter Avenue, Unique ID# 5976

The violation(s) were observed in the field today, January 12, 2026 and are as follows:

Conducting regulated activities (filling of wetlands and/or watercourses) without a Permit from the Wetlands Commission.

This notice requires the halting of all activities within the wetlands or watercourses as well as the specific corrective measures as noted on the attached inspection report. Failure to carry out the action(s) directed in this notice may result in the issuance of a Cease and Desist Order in accordance with Wetlands Regulations Section 14. or other enforcement actions.

In accordance with the requirements of Section 14. of the Wetlands Regulations a hearing is scheduled within ten days of the date of this notice.

You should plan to attend the next regular Wetlands Commission Meeting on **Tuesday, January 20, 2026 at 7:00 P.M. via ZOOM Meeting Format** when this matter will be addressed and you will have the opportunity to address the Commission. See copy of the meeting agenda with links to the ZOOM meeting.

Wetlands Agent Inspection Report

Date: January 12, 2026

Project/property: 69 Charter Avenue

69 Charter Avenue is a 0.21 acre parcel located on the west side of the unimproved Charter Avenue Right-of-Way at the rear of 80 Granby Street and west of 69 Central Avenue.

The Official Map of Inland Wetlands and Watercourses indicates that two thirds of the lot at 69 Charter Avenue is designated as wetlands and there are wetlands and watercourses within the unimproved ROW.

Based on the available aerial photographs both the lot at 69 Charter Avenue and the ROW were fully wooded and the wetlands would have been classified as forested wetlands.

Observations:

Entered the Diesel Transportation, LLC site at 69 Central Avenue to observe the parcel in question at 69 Charter Avenue and took some photos.

The 0.21 acre parcel at 69 Charter Avenue has been cleared and filled with asphalt pavement millings to an apparent depth of 2-3 feet. The wetlands and watercourses in the unimproved ROW have been similarly filled and a narrow channel has been created to convey runoff from wetlands and watercourses north of the 69 Charter Avenue parcel to wetlands and watercourses to the south.

There are many box trucks, semi-trailers and semi-trucks parked on the property and the filling of lot 69 Charter Avenue appears to be an expansion of this use on the site. The areas presently used for vehicle parking, north of the building, have a millings surface and may also have been filled. Some silt fence was observed at the edges of the new millings near the northeast corner of the filled area. See photos attached.

No property corner markers were observed in the field but it is clear that the limits of the filling extend outside of the limits of 69 Charter Avenue. A new property and topographic survey and property corner markers are required to determine the limits of the fill material and extent of the removal.

It appears that the on-going operations of Deisel Transportation, LLC may have encroached into other areas of wetlands and/or watercourses and a Wetlands Permit application for these apparent regulated activities is required.

Notice of Violation – 69 Charter Avenue – January 12, 2026

REQUIRED CORRECTIVE MEASURES:

1. A property and topographic survey of 69 Charter Avenue and the adjacent unimproved right-of-way shall be submitted within 30 days to determine the limits of the fill and its removal.
2. All fill materials shall be removed from 69 Charter Avenue and the Charter Avenue right-of-way to their previously existing grades and removed from the site within 60 days.
3. Fill materials within and around 69 Charter Avenue and the disturbed areas of the Charter Avenue right-of-way shall be removed to the depth of the undisturbed organic soil level and stabilized with winter rye seed and hay mulch for temporary stabilization immediately after the fill is removed. If no organic soils are found then 6" of organic topsoil shall be placed prior to temporary stabilization.
4. The parcel at 69 Charter Avenue and the disturbed areas of the Charter Avenue right-of-way shall be planted with trees and shrubs to restore the forested wetland, watercourse and Vegetated Buffer Zones and shall be permanently stabilized by May 15, 2026. The number and species of these plantings shall be coordinated with the Wetlands Agent.
5. Soil erosion and sediment control measures in accordance with the 2024 DEEP Guidelines, shall be installed, including but limited, to the perimeter of the filled areas for the fill removal, and stone check dams within the constructed channel.
6. A site plan clearly depicting all of the on-going operations of Diesel Transportation, LLC and an application for a Wetlands Permit shall be submitted within 90 days.
